Landes Talcahuano

In the Rocuant Island sector, in Talcahuano, Biobío Region, Landes has four production plants, for products for human consumption, such as frozen jack mackerel, giant squid, hake, pomfret, and albacore. It also has protein processing plants for animal consumption and agricultural biofertilizers.

In 2022, it froze 620 tons per day thanks to investments in the frozen tunnels. The share of jack mackerel will increase for 2023 (between 10% and 15%) and due to these investments the company is ready for higher production with world-class quality standards.

Landes has consolidated the production of proteins intended for animal consumption, successfully sustainably managing mass mortalities of the salmon industry and its by-products.

Chile is currently the world's secondlargest producer of mussels and the main exporter of this product, with production concentrated in the Los Lagos Region on the island of Chiloe.

Landes Mussels is located in Dalcahue, a subsidiary of Landes that grows, extracts, and processes mussels between November and August each year.

In the last four years, the Landes Mussels team has transformed this plant into a reference at a local and national level.

The production of Circular Protein is concentrated in Talcahuano, where salmon silage hydrolysate, salmon mortality, and salmon process plant by-products (head, tail, skeletons, viscera, trimming) are processed, in addition to shrimp offcuts for fishmeal

2022 was a good year for Circular Protein not only because the production of proteins destined for animal consumption was consolidated, but also because it expanded its supplier portfolio to ACME Chile, a subsidiary of the ACME Smoked Fish Holding Corporation, Camanchaca, and Mowi ASA, a leader in the production

With the war between Russia and Ukraine, the company adjusted the offergaining demanding customers from France, due to product quality and having the ASC certification.

Today this country is the main destination for Landes Mussels. In 2022, the local market and Africa accounted for 82% of the market for the Company.

Meanwhile, in animal consumption, after the pandemic, there was a significant increase in the demand for pet food, a situation that has continued alongside a price increase with the war generating an oil shortage and salmor byproduct values to quadruple.

For 2023, the company is looking to double the mussels supplied to Europe; grow on having an MSC certification for jack mackerel and consolidate its position as a fish oil supplier.

Landes Talcahuano: Quality in our DNA

2022 meant the operational consolidation of the Quality area, especially of Circular Protein, a subsidiary of Landes, 90% of whose products go to the United States. To comply with the United States' new Food Safety Modernization Act (FSMA), 15 people from the Quality team in Talcahuano qualified as PCQI, i.e., they are all trained to take responsibility for the controls that are carried out in the plant. In 2022, Landes invested \$250 million to renew its laboratory at the Talcahuano plant, to obtain, in the mid-term, accreditation of the ISO 17025 standard, which introduces a series of technical requirements

Landes Mussels: certification to suppliers

Landes Mussels and its farms comply with all the regulations and requirements set by the General Fisheries and Aquaculture Law and valuable work has been done to certify small producers, from whom 90% of the raw material that the plant processes are bought, under the ASC international standard.

Implementation of New ERP

At the beginning of 2022, the company began working with a new world-class ERP, Dynamics 365 from Microsoft, which was implemented in conjunction with the Administration and Finance Area. The process required a major training program for our employees and an important change in the way we work.

Centralization of reporting

The implementation of Dynamics 365 and other Microsoft platforms has made it possible to generate our first fully automated reports in PowerBI, Microsoft's data analysis service aimed at providing interactive visualizations and business intelligence capabilities with a friendly interface.

Fresh Service - Support Desk

To provide a high level of service to the company's internal users, the Technology and Information Systems departments implemented a case management platform to meet user requirements in a timely and documented manner.

Operational Excellence

In 2022, the implementation of the Lean Management - TPM model began in Landes' operations, a methodology based on 3 fundamental pillars:

- Safety and training of personnel.
- Efficiency of Processes.
- Focused improvement projects.



Connectivity Improvements

In 2022, Starlink was implemented, a satellite internet technology that made it possible to deliver connection for the first time to the farms located on islands in the Los Lagos Region, geographical areas that until then were incommunicado.

Training and Development

During 2022, our teams were provided with technical training tools to develop their labor skills and incorporate value into the trades related to the work of the industrial and mussel fishing processes.

Gender Equity, Diversity, and Inclusion

At Landes, 26% of the workforce is female and the company has embarked on a cultural change throughout the organization (Board, management, leaders, and area managers and operators) to break down barriers and make Landes a more inclusive and equitable company.

In the 2022 Climate Study, we had an increase of 17 percentage points in the gender equity dimension, driven by all the work done since 2019. We have also strengthened the complaints channel and conducted training and awareness-raising talks.

For 2023, the goal is to be certified under the gender equality and work-family-life balance management system (NCh 3262 Standard); raise awareness among all employees, and increase the incorporation of women to our workforce.

Carbon Footprint Measurement

This footprint measurement covers Scopes 1, 2, and 3:

Scope 1 Emissions

This considers direct emissions that come from sources that are owned or controlled by the company, such as, for example, the consumption of fossil fuels in fixed and/or mobile sources.

Scope 2 Emissions

This covers indirect emissions from the generation of electricity, steam, heating, and cooling purchased and consumed by the company.



These come from a company's value chain and are not under the company's control, for example, employee movements or use of products.

Odor management

For a decade, the company has invested in systems to minimize these impacts, through the reduction of odors and carrying out preventive maintenance. In addition to the scrubber system -a technology that, by washing with ozone and seawater, minimizes the emission of annoying odors by more than 90%- two UV plants have been added that work through a photolytic oxidation system to

reduce the smell of the LIWs plant, wells, and coolers.

When the neighbors notice a situation, the complaints procedure for bothersome odors is activated, which coordinates the work of all the areas involved in the production to give appropriate answers to those possibly affected.
